- 11.038 Minutes of Previous Meeting:
- (a) It was unanimously agreed that the Minutes of the meeting held on Thursday 3th March 2011 at 7.00pm in Itchen Abbas & Avington Village Hall be signed as a true and accurate record.
- 11.039 Apologies: Apologies were received from Councillor Sarah Robinson (SR) and County Councillor Jackie Porter (JP).
- 11.040 Public Participation:-
- (a) Mrs Parker had come to support and answer questions on the Itchen Abbas House planning application.

Councillor John Harris asked for details as to how vehicle would gain access. Mrs Parker answered that it was from the B3047.

Councillor Loader said that it was a very well worked out application and that everyone is very supportive.

(b) Mrs Angela Wheeler felt that the recent planning application for the Prince's Mead School which she supported in general was flawed in one area, and that this is its proposal to provide public catering as a service to the community. This in her opinion will be detrimental to the highly competitive catering market in the Itchen Valley area which is already well served by the three village halls and local public houses. She also felt that the high use of commercial extractor fans that

would be required for this type of operation with their associated noise and odours would be detrimental to the quality of life for the neighbouring properties, and that this is unacceptable.

Councillor Harris said that the site will also require a turning circle to allow delivery vehicles that are refused access to the school, to turn around, without having to use the drives of nearby domestic properties.

Grants

The County Councillor's devolved grant closed on March 15th. As there was a sum carried over from 2009-10, there was £11,477 to spend this year. As far as possible, I try to cover the whole division, and this year's recipients were:

Party in the Park, An event for young people in Alresford

£200

Lit sign for 4 Itchen Valley villages to share £2650

Alresfords CAB service set up £2000 East Stratton Village Hall Chairs for Moviola £1200

Northington Village Hall, new oven £1500 Kings Worthy school- bikes for all scheme for year 6 £500

Worthys Festival: a showcase of village groups in Sept 2011 £500 Village Voice Community Mag: equipment upgrade, interim support £650

Eel House, Alresford: grille £1000 Alresford Theatre group £500

Pinder Centre: a pilot scheme: Caring for Carers £827

New applications for 11-12 are invited: the scheme restarts in June 2011, but this year we have a reduced grant sum of only £8000 per councillor. I hope to give a maximum of £1000 for any one scheme to ensure coverage of the division.

Cuts and Consultations

It was depressing to learn this week that despite the swingeing cuts at the County, where HCC has received a reduction in spending of £29 million and actually reduced spending by £55 million, that

the 'state spend' has reduced by just 0.6%. The State Spend includes defence, housing, infrastructure such as roads, rail, legal system etc.

One victim of the proposed HCC cuts is Children's Sure Start Centres: Sunbeams in Alresford has developed the highest reputation in only a year of operation, reaching most of the under 5's (and their parents) either in health or child development. There is still time to make a formal response to the Consultation which ends on 15th April http://www3.hants.gov.uk/childrens-services/childrenandyoungpeople/childrens-centres.htm or you can sign the Save Our Children's Centre petition at www.socchampshire.org.uk, which is being actively supported by the team at Sunbeams.

As Opposition Spokesperson for Children, I have discussed an alternative to the set-up proposed in the Consultation with the Director, based on the Alresford model. I am told that this will be considered seriously, but there are no promises: the HCC proposal is to run the Centres via a Charity, such as Action for Children etc.

There are also consultations on the reduced sums made available by HCC for Subsidised Transport http://consultations.hants.gov.uk/consultationdetails.aspx?consultationid=1046: this will affect CANGO users and Youth Service Provision. There will be links to this via my website asap. The Local Transport Plan is now finalised. It is at http://www3.hants.gov.uk/service493

CAB in Alresford

The service started on 4th April at the Surgery, from 1 to 3pm. It is drop in or by appointment Finally I must add a piece about FACABO- Friends Of Alresford CAB Outreach. You may have received your donation back from NATT, with a letter. There was a Constitution which had been agreed and I want to say thank you to all the groups and Parishes which contributed.

Unfortunately the grant from WCC seemed to make things more difficult, not easier, and NATT couldn't agree with the CAB how the money would be paid to CAB. It is still in dispute, so NATT decided to return the money to donors. This is very frustrating, but as self-appointed administrators of the money they had the right to do that: I hope that all donors who made a decision to pledge money to the Alresford service will reconsider their returned cheque and send it to the CAB to place in a restricted account for the same purpose.

In hindsight, this is what should have happened in the first place, but the offer by NATT to collect the money before paying it to the CAB to make it easier seemed to be the best solution at the time. A misplaced mistrust of the CAB may put this service in jeopardy now, when WCC's £5K runs out, but during this year, I will be doing what I can to get local funding to support the service, back on track. I am most keen to that the original reasons for setting up FACABO remain: not only to support funding from all communities it would serve, but also to promote the service in those same communities. This may not happen if there is no Friends Group.

The WCC Tourism team are getting ready to welcome the World. Four million visitors are expected to visit the city whilst in the UK for the games WCC is taking on six motivated young people to help the Winchester district make the most of opportunities arising from the games.

These assistant posts are available in 2012 through the Future Jobs Fund which is supported by the Department of Work and Pensions at no cost to the City Council

HCC have appointed a teacher Barry Kitchener for a three year assignment to coordinate games related projects and programmes across all Hampshire's departments. A number of countywide events are being planned. Barry will work with all the District and Borough Councils and Unitary authorities on their plans for 2012.
