# **Minutes March 2012**

12.039 Apologies: Councillors Ms K Wells (KW), Mr A Kennedy (AK), Mrs S Robinson (SR), Mr M Porter (MP) and County Councillor (JP).

12.040 Minutes of Previous Meeting:

It was unanimously agreed that the meeting held on Thursday 2nd February 2012 at 7.00pm in the Easton Village Hall be signed as a true and accurate record.

12.041 Public Participation - None

12.042 Reports from County and City Councillor:

Action

- a) County Councillor Porter did not attend the meeting and did not provide a written report.
- b) District Councillor Gottlieb did not present a written report.
- i) Councillor Gottlieb reported that Winchester City Council would not be increasing the Council Tax this year and this had been achieved without any detrimental effect on front line services.
- ii) Winchester City Council is now allowed to build Council Houses and is borrowing 160 million from the Government at a low interest rate of only 3%. This will not only provide work locally but also much needed social housing.
- iii) Bartons Farm is a mess which needs to be sorted out.

iv) He said that the proposed Winchester City centre development is a mess which will ruin its appearance and went on at length to explain why he is opposed to it. He said that he would give a full and proper presentation outlining his objections at a future Parish Council meeting.

Councillor Riley explained that this equates to a total of £250.00 which is the sum budgeted by the Parish Council.

It was unanimously agreed that the grants should be given, once an official request has been received from each of the organisation.

#### b) Parish Plan

Councillor Flemons reported that the first section of the Parish Plan has been completed and that a working party has been set up to develop the next two sections.

## c) Couch Green Playing Field.

Councillor Flemons said that the Playing Field Association has refused the Parish Council's request to turn the playing field into allotments, but she said that they may be prepared to look favourably to it becoming a wild flower meadow because this would not restrict access.

It was the consensus of those present that decision on the playing fields future should put it in abeyance and to wait and see what recommendation emerges from the Parish Plan.

#### d) Footpath Bridge, Church Lane:

Councillor Flemons reported that work on the repair of the footpath bridge at the bottom of Church Lane Martyr Worthy that is in an unsafe condition has been scheduled to commence in March.

Councillor Riley said that the fish are spawning under the bridge and that the work should be delayed for two to three weeks.

District Councillor Gottlieb said that he would write and see if the work could be delayed.

e) Councillor Robinson had emailed informing that she had received a quote from JS Groundwork for putting in new posts at the Park in Easton. The quote was given in two parts the first for re-using the old rails and the second for replacing the old rails.

It was unanimously agreed that Councillor Robinson should be given delegated responsibility to authorise JS Groundwork to undertake the work using new materials.

# f) Improved Footpath

With regard to the money that had been identified from Paddocks Development to provide an improved footpath to the school, Councillor Riley is meeting an officer from Winchester City Council to establish the most practical route.

- g) Councillor Gapper reported that the tenants of the Trout Public House are leaving and that the owners would be seeking new tenants.
- h) Councillor Loader said that he had completed the revised 'Asset Register'.

#### 12.044 Matters for Decision/Discussion:

- a) Parish Plan.
  - The Clerk was asked to keep a separate account of all expenditure on the Parish Plan.
- b) Councillor Loader reported that the outstanding grit bins have still not been delivered.
- c) Councillor Howell said that Martyr Worthy was putting on an historic event on the first weekend in June and that everyone is welcome to attend.

She reported that the footpath from John Harris's house towards the playing field is in a terrible state.

Councillor Flemons recommended that Councillor Howells reports this on the County Council web—site.

d) Councillor Gapper said that a lot of rubbish has been deposited particularly around the bus stops.

It was decided to have a litter picking session on Saturday the 24th March at 10.00am with teams starting from each end and meeting in the middle. Everyone wishing to attend would be welcome to join in.

e) Councillor Riley reported that the telephone box in Martyr Worthy was being used as a litter bin with oil cans being dumped in it.

Councillor Flemons said that this is one of the items that the local community should take responsibility for.

f) Councillor Howell reported that the street light at the top of Church Lane is not working.

Councillor Moffat said that he would replace the bulb.

g) Councillor Flemons said that with regards to the Queen's Diamond Jubilee that she has looked into planting a tree in each of the four villages each tree have a tree guard with a ceremonial plaque commemorating the occasion. She said that she would put an article in the parish magazine to obtain the views on this including if accepted what variety of trees should be planted.

h) Councillor Riley said that Couch Green is very poorly equipped with play equipment and that the Parish Council should be looking to improve this.

Councillor Loader suggested that this should be based on recommendations that come out of the Parish Plan.

Councillors Riley and Howells said that they would get together to look at the type of equipment that is required.
