2. Applications:

The committee noted that there had been 6 applications received by WCC on behalf of the SDNP since it last met. Only one applications paperwork had been received, all felt this was unacceptable, as the Parish Council was missing commenting on important application. The following change of process was agreed:

- Applications to be drawn to councillor's attention via email when they appear on the weekly SDNP email list received by the Parish Clerk.
- The Parish Clerk to log applications as soon as they are listed on the SDNP weekly list, and to place on the next meeting agenda.
- The Chairman of the committee to ask a councillor/councillors to review the application on the planning portal, and to print down any information they feel pertinent to the committee.
- The councillor/s to carry out neighbour consultations as they deem appropriate prior to the meeting.
- If the paperwork is received prior to the meeting it should be given to the councillor conducting the neighbourhood consultations, who should bring it to the planning committee for information.
- The planning committee to discuss with the IA village hall committee the
 practicalities of having Broadband Wi-Fi installed at Itchen Abbas Village Hall in
 order to facilitate accessing the planning portal during meetings. This proposal to be
 put to full council.

It is hoped that the lack of paperwork being received from WCC is a temporary issue but all felt that the Parish Clerk should be asked to write to express our concern given the limitations of rural IT!

The application is within the village boundary and as such we do not support general B2 usage with its potential noise, pollution and heavy vehicle usage so close to the village amenities and housing. Furthermore we believe the application is contrary to SDNP Policy SD27, given the classification of the business falls outside those supported in the SDNP and there is sufficient supply in the local area. The application is also in conflict with the SDNP Employment Land Requirement (ELR) which does not support the further expansion of class B2 premises. The committee felt that the application itself was woefully lacking in detail and failed the "transparency "test. However, the PC understands that a MOT garage is planned for the unit, this gives us additional concern with car parking on an extremely tight site with single track access, used by the village hall and local primary and nursery schools.
