The PC do not object to the principle of an outbuilding on the site used as an office but suggest that its occupation should be restricted to somebody also living in The Warren

However, the flat roofed and vertical cladding design is not in keeping with the vernacular – there are many proprietary garden offices available with horizontal timber cladding and shallow pitched shingle roofs which would be more in keeping with other outbuildings in the locality.

The building should also be required to have proprietary fitted blackout blinds to comply with the SDNP dark skies policy.
